Dimensions: Length 23'0" Height TXT Depth 2'0" Height above grade/roof to top of sign 8.5'0" TOTAL SQUARE FOOT AREA 161 square feet

Such sign shall comply with all applicable provisions of Chapter 17 of the Chicago Zoning Ordinance and all other applicable provisions of the Municipal Code for the City of Chicago governing the construction and maintenance of signs, billboards, signboards and related structures.

Please return the completed Public Way Use application to City Hall - 121 N. LaSalle Street, Chicago, IL 60602 Room 800. The completed application package must include a copy of the completed DOB application and the Public Way Use application. The Public Way Use application must contain the Alderman's signature, site plans on 8 1/2 X 11 paper, photos of the item(s), the signed Acceptance letter and a copy of the insurance certificate.
