ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the M1-2 Limited Manufacturing / Business Park District symbols and indications as shown on Map No. 5-H in the area bounded by the alley next north of and parallel to West Wabansia Avenue; a line 100.64 feet west of and parallel to North Damen Avenue; West Wabansia Avenue; and a line 124.67 feet west of and parallel to North Damen Avenue, to those of a RT-4 Residential Two-Flat, Townhouse and Multi-Unit District and a corresponding uses district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

In accordance with Amendment to the Zoning Code enacted by the City Council, Section 17-13-0107-A, please be informed that on or about July 19, 2011, I, the undersigned, filed an application for a change in zoning from a M1-2 Limited Manufacturing/Business Park District to a RT4 Residential Two-Flat, Townhouse & Multi-Unit District, on behalf of the Applicant/Owners, Nicole Moret Schumacher & Adam Schumacher, for the property located at 2018 West Wabansia Chicago, IL.

The existing two-story masonry building shall remain. The reason for the zoning amendment is to permit a) the de-conversion of the existing two-unit residential building to a single family home; b) to permit the construction of a two-story masonry addition to the existing 2-story masonry building and c) to permit the construction of a new one-story masonry garage which will contain two parking spaces. The height of the

building shall remain at 31' 6 Vi" . The reason for the zoning amendment is to allow for the two-story addition, which is not allowed under the current M1-2 District.
